It shall be adopted within the Citrus County Code as a technical manual. This manual and specifications shall apply to all new and/or modified utility infrastructure proposed for the Citrus County Utility service area and serves to insure adherence to the County Comprehensive Plan in the planning of utilities within the County.

Included in the manual is a material checklist to follow for the engineering and development community. Adherence to these materials will reduce design and review time by removing the need for shop drawing reviews by the Citrus County Utilities Division.
